Terms and Conditions

The following are the terms and conditions of entry for Griffo's Challenge 2017. These terms are not negotiable and by accepting an entry to the event via registration system on-line and paying a registration fee/donation you hereby acknowledging your acceptance of our terms and conditions.

WARNING: This is a legal document that affects your rights, if you are uncertain or uncomfortable with some of the conditions of registration then we recommend that you obtain advice to ensure you understand and accept the conditions of entry.

I agree to participate in this event on the following basis:

1. This is NOT a race but a participation event.
2. The event categories are simply a guide. I acknowledge that I can choose my own participation distance and make my own determination as to whether I will walk, jog or run or a combination of the above.
3. By registering to participate, I will pay the fee to support this event and agree that if I do not do so I could be refused entry to participate. I agree to encourage and invite other person/s to sponsor me for my participation of this event.
4. I will participate and contribute to the event in a positive and co-operative manner and with a spirit of goodwill and camaraderie;
5. I acknowledge that competitive or other sporting events involve the real risk of serious injury or even death from various causes including overexertion, equipment failure, dehydration, accidents with other competitors, spectators or road/pathway/bikeway users, and course or weather conditions and other causes.
6. I understand that I should not participate in this event unless I have trained appropriately and will be in a fit state to complete the event safely. I warrant that I am fit and healthy and physically capable of participating in such an event. I acknowledge that if I am aware of an existing medical condition and uncertain of my state of fitness then a medical practitioner should verify my physical condition and provide me with a clearance to participate.
7. By participating, I accept all risks necessarily flowing from my participation that could result in injury, loss of life or permanent injury. Accordingly, I release all persons or corporations associated directly or indirectly with the conduct of the event from all claims demands and proceedings arising out of my participation and I hereby indemnify them against, all liability (including liability for their negligence and negligence of others) for all injury, loss or damage arising out of or connected with my participation in this event. This release shall extend to and include the Griffo's Challenge Committee, Icon Cancer Foundation, Cure Brain Cancer Foundation, their members, event volunteers and other participants, event sponsors, event marshals and their respective directors, partners, managers, officers, agents, contractors, employees and volunteers including event medical and paramedical personnel. This release and indemnity continues forever and binds my heirs, executors, personal representatives and assigns.
8. I will immediately withdraw from this event should at any stage I feel any stress, discomfort or pain that exceeds any level that a normal person would expect to experience arising from such physical participation/exertion.
9. I consent to receiving any medical treatment including ambulance transportation that event organisers think desirable during or after the event.

10. I have provided or attached to my entry form details of any medical or physical conditions from which I suffer that might affect my performance or be relevant if medical treatment is needed. I accept the risk of participating despite these conditions.
11. I understand that insurance cover for participants in this event may not cover for all injury, loss or damage sustained by me.
12. Safety precautions undertaken by organisers (such as course supervision, race safety briefings) are a service to me and other participants but are not a guarantee of safety.
13. My registration is not transferable to other people. Any attempt to transfer my entry or allow another person to participate under my name without the event organisers knowledge may result in a refusal to participate and no refund of funds donated to participate.
14. This is a charity fundraising event. No refunds will be offered once a donation is made and/or received by Icon Cancer Foundation or Cure Brain Cancer Foundation. I forfeit any and all claims against Cure Brain Cancer, Icon Cancer Foundation or the event organisers (Griffo Challenge Committee).
15. Event organisers may change the event format, course or other race conditions at their discretion. If that occurs, this agreement applies to the changed conditions.
16. I agree that if the event is cancelled due to storm, rain, inclement weather, winds or other 'Act of God' conditions or safety concerns, or if I do not participate in the event for any other reason, my donation/registration fee shall be non refundable.
17. I agree to abide by all race rules and directions issued by the event organiser.
18. I certify I will read and abide by the Waiver Conditions and Indemnity as part of my registration for this event.
19. I acknowledge and consent to photographs and electronic images being taken of me before, during or after the event by an official representative of the event organiser. I acknowledge and agree that such photographs and electronic images are owned by the event organisers and that the event organiser and event sponsors may use the image for promotional use.
20. I am fully responsible for the security of my personal possessions at the event including all valuable or other items. I agree that I am fully responsible for any possessions I have left in or around the course or at the marshalling area. The event organisers will not be liable for replacement of any personal or other possessions.
21. I certify that I am 18 years of age or older, and I have read this document and understand and accept the terms and conditions it contains.
